THE M3 USES A TWEETER EQUIPPED WITH A DIAMOND COATED BERYLLIUM DOME, ALLOWING A FREQUENCY RANGE EXTENDING BEYOND 40kHz. IN ITS SOLID FORM, BERYLLIUM IS HARMLESS. HOWEVER, DUE TO ITS NATURE, CERTAIN SPECIAL PRECAUTIONS SHOULD BE OBSERVED TO AVOID EXPOSURE TO UNNECESSARY RISK, SUCH AS:

- UNDER NO CIRCUMSTANCES SHOULD THE BERYLLIUM DOME BE SUBJECTED TO ANY FORM OF ABRASIVE ACTION.
- IN THE UNLIKELY CASE OF DAMAGE TO THE DOME, OF ANY FORM, A WIDE PIECE OF ADHESIVE TAPE SHOULD BE IMMEDIATELY USED TO SEAL THE WHOLE FRONT SURFACE OF THE TWEETER. MAGICO M3 USER'S GUIDE

UNPACKING INSTRUCTIONS

- 1. THE FOLLOWING TOOLS ARE REQUIRED: A PRY BAR, 3/8" DRIVE RATCHET OR DRIVE ADAPTER AND CORDLESS DRILL, 9/16" OR 14MM SOCKET, 3/4" OR 19MM SOCKET, 1/4" HEX WRENCH, 3/8" HEX WRENCH, 5/16" HEX WRENCH, AND 3 PEOPLE.
- 2. USING A FLAT HEAD SCREWDRIVER OR PRY BAR, REMOVE THE 6 CLAMPS FROM THE FRONT OF THE CRATE AND REMOVE THE CRATE DOOR.







- 3. REMOVE THE DOOR. THE INSIDE OF THE DOOR HAS A TAB, PLACE THIS TAB DOWN AND INSIDE THE KEYWAY SLOT THAT IS IN THE CRATE BASE.
- **4.** THE DOOR NOW BECOMES A RAMP THAT IS LOCKED IN PLACE WITH THE CRATE BASE.



- 5. USING A 3/8" DRIVE RATCHET OR CORDLESS DRILL WITH A 9/16" SOCKET BIT REMOVE THE 6 BOLTS FROM AROUND THE BOTTOM OF THE CRATE.
- **6. WITH TWO PEOPLE**, LIFT AND REMOVE THE CRATE BOX TOP AND REMOVE FOAM FROM DOOR RAMP.







7. YOU WILL NOTICE THAT CASTER WHEELS ARE SECURED TO THE CRATE BASE WITH A "U-BRACKET" OR STRAP CLAMP, A FASTENER, A CHOCK BLOCK AND A ZIP TIE.



- 8. REMOVE THE ZIP TIES

 SECURING THE CHOCK BLOCKS

 TO THE CASTER WHEELS. USE

 WIRE CUTTERS, SCISSORS, OR A

 BLADE TO CAREFULLY REMOVE


 THESE TIES.
- 9. REMOVE THE FASTENERS THAT ARE SECURING THE CASTER OUTRIGGERS TO THE CRATE BASE USING A 9/16" SOCKET AND RATCHET.
- **10.** REMOVE CHOCK BLOCKS FROM UNDERNEATH CASTERS.
- 11. REMOVE THE BOLTS

 FASTENING THE STRAP CLAMPS

 OR "U-BRACKETS" ON ALL FOUR

 CASTER WHEELS USING A 9/16"

 SOCKET AND RATCHET.










12. UNLOCK THE CASTER WHEEL BRAKES, PUSH THE SPEAKER 3 INCHES TOWARDS THE RAMP, SET BRAKES TO "ON" POSITION, NOW SLIGHTLY TILT THE SPEAKERS TOWARDS THE REAR SO THAT THE WEIGHT ON THE FRONT WHEELS IS ALEVIATED, UNLOCK BRAKES AND PIVOT THE FRONT CASTER WHEELS TO FACE THE BACKSIDE/REAR OF THE SPEAKER AND LOCK THE CASTER WHEEL BRAKES.





- **13.** WITH TWO PEOPLE, ONE PERSON ON EITHER SIDE OF THE M3, TRANSPORT SPEAKER DOWN THE RAMP AND OFF OF THE BASE.
- 14. POSITION SPEAKERS IN DESIRED LOCATION.






15. SET ALL BRAKES TO "ON" POSITION AND REMOVE THE VELVET BAG.

MPOD OWNERS

16. USING THE HELP OF 2 OR MORE PEOPLE, TILT SPEAKER BACKWARD, UNINSTALL FRONT CASTER WHEELS AND INSTALL M-PODS BY CAREFULLY THREADING THEM INTO POSITION. ALTERNATIVELY, IF YOU DO NOT HAVE THE M-POD PACKAGE GO TO STEP 22.







17. TILT SPEAKER FORWARD, UNTHREAD AND REMOVE THE SHIPPING BARS FROM THE BOTTOM OF THE M3. YOU WILL NEED A 3/8" HEX BIT TO REMOVE THE LARGE FASTENER ON THE SHIPPING BAR. YOU WILL NEED TO USE A 5/16" HEX BIT TO REMOVE THE SMALLER SHIPPING BAR FASTENER. INSTALL THE M-POD BY CAREFULLY THREADING IT IN TO POSITION. M-PODS WITH A SHORT STUD MUST ONLY BE INSTALLED IN THE REAR SECTION OF THE STAND. M-PODS WITH LONGER STUDS ARE TO BE INSTALLED IN THE FRONT TWO STAND OUTRIGGERS.









18. USING A ¼" HEX WRENCH, ADJUST AND LEVEL THE M-POD BY TURNING THE EXPOSED STUD.



19. WHEN THE IDEAL POSITION HAS BEEN ACQUIRED, CAREFULLY THREAD ON THE M-POD TOP.





20. REMOVE THE ANCHOR PIN FROM THE M-PODS. THIS PIN MUST BE REPLACED BEFORE ANY ATTEMPTS TO ADJUST POSITIONING OF THE SPEAKER.






21. REMOVE THE TWEETER PROTECTOR AND SECURITY TAPE AND PROCEED TO STEP 35.


M3 SPIKE OWNERS

- **22.** SPIKE OWNERS HAVE A CHOICE OF CHOOSING WHICH TYPE OF FOOT TO USE. THE BALL END FOOT IS FOR USE ON HARD FLOORS WHILE THE SPIKE IS FOR USE ON A CARPETED SURFACE.
- 23. TO ASSEMBLE THE M3 SPIKE, CHOOSE THE FOOT THAT WILL WORK BEST WITH THE TYPE OF FLOORING YOU HAVE.
 THREAD THE HEX JAM NUT ON TO THE FOOT OF YOUR CHOICE AND THREAD IT ALL THE WAY TO THE LAST THREAD (WHERE THE TAPER BEGINS).
- **24.** THREAD THE FOOT AND JAM NUT ASSEMBLYE IN TO THE M3 SPIKE BODY (BLACK AND COPPER UNIT). YOU NOW HAVE A FINISHED M3 SPIKE READY FOR INSTALL.









- 25. USING THE HELP OF 3 OR MORE PEOPLE, POSITION ALL FOUR CASTER WHEELS SO THAT THEY ARE FACING INWARD. THIS WILL ALLOW FOR THE SPEAKER TO TILT WITH EASE.
- 26. TILT SPEAKER BACKWARD,
 UNINSTALL FRONT SHIPPING BARS
 BY REMOVING THE (2) LARGE AND
 (2) MEDIUM SIZE FASTENERS
 FROM THE SHIPPING BARS. USE A
 3/8" HEX BIT TO REMOVE THE
 LARGE FASTENERS, USE A 5/16" BIT
 TO REMOVE THE MEDIUM
 FASTENERS. HOLD THE CASTER
 WHEEL WHEN REMOVING THE
 SHIPPING BAR, THIS WILL
 ALLEVIATE ANY PRESSURE ON THE
 FASTENER AND WILL MAKE THE
 REMOVAL OF THE FASTENER
 MUCH EASIER.









- **27.** WITH THE M3 STILL BEING TIPPED BACK AND THE SHIPPING BARS REMOVED, CAREFULLY THREAD IN THE M3 SPIKE ASSEMBLY IN TO BOTH LOCATIONS ON THE BASEPLATE.
- **28.** GENTLY LOWER THE CABINET DOWN ON TO ITS SPIKES, HAVE 2 PEOPLE HOLD THE SPEAKER FOR STABILITY.









- **29.** HAVE TWO PEOPLE TIP THE M3 FORWARDS ON TO THE SPIKES, HAVE BOTH PEOPLE HOLDING AND STABILIZING THE M3.
- 30. REMOVE THE REAR SHIPPING BARS.

 UNFASTEN (2) LARGE AND (2) MEDIUM
 FASTENERS THAT ARE SECURING THE
 SHIPPING BARS WITH A 3/8" HEX BIT (FOR
 THE LARGE FASTENER) AND A 5/16" HEX
 BIT (FOR THE MEDIUM SIZE FASTENER).
 HOLD THE CASTER WHEELS WHEN
 REMOVING THE SHIPPING BAR TO
 ALEVIATE PRESSURE ON THE FASTENERS.
- **31.** CAREFULLY THREAD IN THE M3 FOOT ASSEMBLY.
- 32. SLOWLY LOWER THE CABINET ON TO ALL FOUR SPIKES. ADJUST THE HEIGHT OF EACH SPIKE TO LEVEL THE M3. THREAD THE SPIKE IN TO LOWER HEIGHT AND THREAD SPIKES OUT TO RAISE HEIGHT. WHEN THE SPEAKER IS LEVEL, LOCK THE SPIKE IN PLACE BY FASTENING THE LOCK NUT AGAINST THE FOOT ASSEMBLY WITH A 19MM OR 3/4" WRENCH.
- **33.** CAREFULLY LOWER THE M3 DOWN ON ALL FOUR SPIKES.
- 34. REMOVE THE TWEETER SECURITY TAPE.









- **35.** A TORQUE WRENCH IS INCLUDED IN EACH ACCESSORY KIT TO CHECK TORQUE ON EACH OF THE 8 FLAT FASTENERS ON THE BACK OF THE M3.
- **36.** SET THE TORQUE WRENCH FOR 115 INCH POUNDS.
 - LOOSEN THE LOCK AT THE BOTTOM OF THE TORQUE WRENCH.
 - TURN THE HANDLE SO THE "5" LINES UP WITH THE "110" ON THE INCH-POUND SCALE.
 - TIGHTEN THE LOCK AT THE BOTTOM OF THE TORQUE WRENCH.







- **37.** ATTACH THE BIT AND DRIVE TO THE TORQUE WRENCH DRIVE SHAFT.
- 38. CHECK THE TORQUE OF EACH OF THE 8
 FLAT FASTENERS ON THE BACK OF THE M3.
 THE WRENCH WILL CLICK TO LET THE USER
 KNOW THAT THE TORQUE SETTING OF THE
 FASTENERS IS UP TO DATE. NOW SET THE
 WRENCH TO ITS LOWEST SETTING TO
 PRESERVE ITS ACCURACY DURING
 STORAGE.
 - LOOSEN THE LOCK AT THE BOTTOM OF THE TORQUE WRENCH.
 - TURN THE HANDLE SO THE "0" LINES UP WITH THE "20" MARK ON THE INCH-POUND SCALE.
 - TIGHTEN THE LOCK AT THE BOTTOM OF THE TORQUE WRENCH.







SPEAKER PLACEMENT AND POSITIONING

THE MAGICO M3 LOUDSPEAKERS ARE PRECISION INSTRUMENTS FOR MUSIC REPRODUCTION. AS SUCH, PROPER CARE AND ATTENTION TO DETAIL WHEN SETTING UP THESE SPEAKERS WILL YIELD THE MAXIMUM PERFORMANCE, REGARDLESS OF THE PARTICULAR ROOM. FOLLOWING THESE SET-UP GUIDELINES WILL ENSURE THE SPEAKERS ARE PROPERLY POSITIONED TO DELIVER THE OPTIMUM LISTENING EXPERIENCE. ALL THAT IS REQUIRED IS A TAPE MEASURE, A PEN, A CALCULATOR, A BALL OF STRING, A COUPLE OF DEMO CDS, AND SOME PATIENCE.

PLACEMENT—M3s IN RELATION TO BACK AND SIDE WALLS

BEFORE YOU BEGIN: LOOK FOR OBVIOUS IMPEDIMENTS INCLUDING ANYTHING THAT COULD IMPEDE OR DIMINISH THE SOUND—E.G., OTHER SPEAKERS, AMPLIFIERS, EQUIPMENT RACKS, ANYTHING ON THE WALL THAT COULD CAUSE A REFLECTION, A SEVERE MISMATCH IN QUALITY AMONG INDIVIDUAL COMPONENTS, AND UNNECESSARY OR POORLY RUN SPEAKER/INTERCONNECT CABLES.

BASS—DISTANCE FROM REAR WALL

THE INITIAL PLACEMENT SHOULD BE APPROXIMATELY 20 INCHES (1/2 M) FROM THE BACK OF THE LOUDSPEAKER TO THE BACK WALL. SINCE WE HAVE SHORT AUDITORY MEMORY, THE SELECTED DEMO MUSIC CUT SHOULD BE BRIEF—30 SECONDS – 1 MINUTE MAX. IT SHOULD BE A WELL RECORDED JAZZ CUT WITH GOOD BASS GUITAR OR PERCUSSION. WHAT WE ARE LISTENING FOR AT THIS TIME IS THE DEFINITION OF THE BASS AND THE RIGHT SENSE OF PROPORTION.

NEXT, MOVE THE SPEAKER 6 – 8 INCHES (15 – 20 CM) FORWARD AND REPEAT THE LISTENING PROCESS. REPEAT THIS PROCESS, MOVING THE LOUDSPEAKER FORWARD IN 6 – 8 INCH (15-20 CM) INCREMENTS. WHEN YOU REACH THE POINT FROM WHICH MOVING THE SPEAKER FORWARD SOUNDS WORSE THAN THE PREVIOUS LISTENING POINT, MOVE THE LOUDSPEAKER BACK TO THIS POSITION AND MARK THIS DISTANCE FROM THE REAR WALL.

MIDRANGE—PLACEMENT IN RELATION TO SIDE WALLS FOR LATERAL PLACEMENT

BEGIN BY DIVIDING THE ROOM WIDTH BY 14. INITIAL PLACEMENT OF THE LOUDSPEAKERS WILL BE AT 3 AND 11. THE DISTANCE FROM THE LOUDSPEAKER TO THE EARS HAS TO BE PRECISELY EQUAL. THIS MEASUREMENT IS CRITICAL. THE MUSIC FOR THIS PROCESS SHOULD BE A FEMALE VOICE AND PIANO. WE ARE LISTENING FOR THE IMAGE OF HER VOICE TO BE FOCUSED. THE RULE FOR THE TOE-IN IS TO PICK A POINT APPROXIMATELY 1-2 FEET (. M) BEHIND THE LISTENER'S HEAD. TOE THE

LOUDSPEAKERS IN TO INTERSECT AT THAT POINT. IF THE SOUND IS TOO BRIGHT, TOE THE SPEAKERS OUT A LITTLE MORE. IF THE SOUND IS TOO DULL, TOE THE SPEAKERS IN A LITTLE MORE. REPEAT THE ABOVE PROCESS WITH THE LOUDSPEAKERS AT THE 4 AND 10 POSITION. THEN REPEAT, ONCE AGAIN WITH THE SPEAKERS AT THE 5 AND 9 POSITION.

SUMMARY

ONCE THE INITIAL PROCESS HAS BEEN COMPLETED, RETURN TO THE BASS SET-UP TO ENSURE THAT THE LOUDSPEAKERS ARE THE PROPER DISTANCE FROM THE BACK WALL. WHEN THE PROCESS HAS BEEN COMPLETED, MARK THE SPEAKER LOCATION WITH TAPE SO THAT THE SPEAKERS CAN BE RETURNED THERE FOR FURTHER LISTENING.

POSITIONING—M3s IN RELATION TO THE LISTENER

- THE SPEAKERS AND THE LISTENER SHOULD FORM AN ISOSCELES TRIANGLE.
- THE LISTENER SHOULD BE EXACTLY EQUIDISTANT BETWEEN THE TWO LOUDSPEAKERS. THE BEST WAY TO DETERMINE THIS IS WITH A PIECE OF STRING. PICK A FIXED SPOT AT THE LISTENING POSITION. RUN THE STRING FROM THIS SPOT TO THE FRONT OF THE TWEETER OF THE LEFT SPEAKER. REPEAT THE PROCESS FOR THE RIGHT SPEAKER. IT IS CRITICALLY IMPORTANT TO KEEP THIS DISTANCE PRECISELY THE SAME.

CONNECTIONS

CONNECTIONS SHOULD BE MADE WITH ALL ELECTRONIC EQUIPMENT (AMPLIFIERS, PREAMPLIFIERS) TURNED OFF. THERE ARE TWO TERMINALS AT THE BACK OF THE SPEAKER. THE TERMINALS ARE INSULATED TO ACCEPT A VARIETY OF CABLE TERMINATIONS FOR MOST APPLICATIONS AND TO PREVENT ANY LIKELIHOOD OF ELECTRICAL SHOCK, EVEN WHEN THE SPEAKERS ARE USED WITH THE HIGHEST POWERED AMPLIFIERS. DO NOT USE TOOLS TO TIGHTEN THE BINDING POSTS.

BREAK-IN

A LOUDSPEAKER IS A MECHANICAL DEVICE AND AS SUCH REQUIRES AN EXTENDED INITIAL PERIOD OF NORMAL USE DURING WHICH A NOTICEABLE IMPROVEMENT IN SOUND QUALITY WILL OCCUR. DO NOT ATTEMPT TO ACCELERATE THE BREAK-IN PROCESS BY PLAYING SINE WAVES, TONE SWEEPS, BREAK-IN CDS OF ANY SORT, OR OTHER GENERATED SIGNALS.

CARE:

FOR ALUMINUM PANELS USE A LINT-FREE SOFT CLOTH (PROVIDED IN ACCESSORY KIT). FOR PAINTED SURFACES, USE A PRODUCT SUCH AS MEGUIAR'S PROFESSIONAL FINALINSPECTION 34. DO NOT USE CLEANERS THAT CONTAIN AMMONIA, STRONG SOLVENTS, OR ABRASIVE MATERIALS. USE OF THESE CLEANERS CAN DEGRADE, SCRATCH, OR DESTROY THE FINISH.
